Subject of Thesis: **The offset agreements in an international trade context** under the direction of Professor François Ameli.

#### **Current Research**

Nowadays governments nearly always require foreign companies to sign an offset contract as a condition for signing a public procurement contract in the country concerned. The aim is to compensate for the resulting loss of activity for the national economy when a public procurement contract is awarded to a foreign company by obliging that company to invest in the buying country. In practice this investment can be a transfer of the technology used to manufacture the product being sold and/or localized manufacturing of the product in the buying country. This is what is known as direct offset since there is a direct link with the public procurement contract. Investment can also benefit the national economy without having any link to the public procurement contract; in this case we talk about indirect offset. The logic behind these contracts is a form of indirect taxation which benefits the development of the buying country. Offsets are imposed by the buying country which validates correct performance of the offset contract as regards the expected benefit for the national economy.

During my PhD, I work within the offset department of AREVA.

I am currently investigating the contentious legal relationships between government procurement and the related offset contracts.

#### Research ambition

My plans include national development of the purchasing country, technology transfer, localisation and new legal solutions.
